REGISTRATION CANCELLATION POLICY

We understand that people's circumstances can change and provide the following alternatives to help you.

All changes and cancellations to registrations for the 22nd Australasian Weeds Conference (**Event**) should be made in writing to the conference organiser, AgCommunicators Services Pty Ltd. Do not submit another registration form unless instructed to do so. If a delegate is no longer able to attend, they can transfer their registration to another delegate through an email to the conference organiser.

For any cancellation of registration prior to September 10, 2021 the registration fee will be refunded less a 12% administration fee (including GST). For any cancellation of registration on or after September 10, 2021, the full registration fee is non-refundable. No refunds will be made for non-attendance at the conference or activities.
